



# Year 5 STEM Session Takes to the Skies!

On Tuesday 22<sup>nd</sup> November, Year 5 part in a STEM science day hosted by the Smallpeice Trust. The children worked alongside the RAF youth engagement team to build their own rockets, they learnt about the different parts of the rocket also, how the angles of the rocket



launch and the weight can affect the distance travelled. This learning helped support the maths, science, engineering and technology learning we have been doing in class. Also, the children had a chance to design their own sustainable aircrafts to be in with a chance to win a prize, tickets to the RAF tattoo. The Year 5s are now really knowledgeable about sustainability and jobs in engineering, with many children inspired to be future engineers!

- to name The Vale Primary School as a feeder school to Rosebery School (this allows the Trust to support its children at The Vale Primary School to access Key Stage 3 education, given its isolated location);
- the addition of a third placed oversubscription criteria to allow the school to name a feeder school into their Sixth Form (this allows the Trust to continue to offer Key Stage 5 education to its students in the local area); and
- to name The Beacon School as a feeder school to Rosebery School (*The Beacon School is closing its Sixth Form and this will allow the Trust to offer those students access to Key Stage 5 provision*).

This consultation is taking place in accordance with the requirements as set out in the <u>School Admissions</u> <u>Code</u>. The consultation must take place for six weeks and it is good practice that this six week period excludes school holidays.

Epsom and Ewell in WW2 find out what it was really like! December Tuesday 20th 2022 10.30am to 12pm

The Borough suffered heavily from bombing in World War 2 and from 1940 to 1944, 890 alerts were sounded, 384 people were injured by enemy action and 33 killed. There were more than 200 incidents with 12,234 houses slightly damaged, 413 devastated and 192 completely destroyed, while thousands of incendiary and anti-personnel bombs were

dropped with 440 high explosive, 64 oil and 30 flying bombs falling on the

In 1914 Epsom was a small, self-contained town of 20,000 citizens, Ewell a village of 4,000 inhabitants People went to concerts and the newly invented moving pictures at the Public Hall, were loval to a bewildering choice of eleven different churches and chapels, played football, cricket and tennis, and belonged to dozens of Clubs, Brotherhoods and Orders. The big family names, such as Glyn or Bridges, no longer owned most of the land; tradesmen were in the majority on the Urban and Rural District Councils. In the new municipal Rosebery Park, children sailed their boats
